SCAM ALERT!

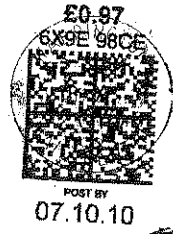
A Florissant resident recently received a letter in the mail indicating they were one of the winners \$50,000 in the “UK & North America Consumer Promotion Draw.” Please beware, IT’S A SCAM!

The letter indicated they had been selected based on a recent purchase at a local department store and their information was gathered from a sales slip from one of the stores. A check was included with the letter which the person was suppose to deposit then use Western Union to wire the money back to be applied to the taxes for their winnings.

Beware if you receive something similar and look for these signs that indicate it’s a scam:

- A letter postmarked out of the U.S.A.
- A notification that you’ve won although you never entered the contest,
- An enclosed check you are to cash and then **WIRE** the money back to cover the taxes for your winnings. This is usually a sure sign a scam is in effect,
- The letter is generic; your name is not listed on the letter.


