COUNCIL MINUTES

February 13, 2017

The Florissant City Council met in regular session at Florissant City Hall, 955 rue St. Francois

on Monday, February 13, 2017 at 7:30 p.m. with Council President Pagano presiding. The Chair asked

everyone in attendance to stand and join in the Pledge of Allegiance. On Roll Call the following Councilmembers were present: Eagan, Caputa, Schildroth, Pagano,

Schmidt, Siam, Lee and Jones. Councilman Henke was excused. Also present was Mayor Thomas P.

Schneider, City Attorney John Hessel and City Clerk Karen Goodwin. A quorum being present the

Chair stated that the Council Meeting was in session for the transaction of business.

Councilman Lee moved to approve the Meeting Minutes of 1/23/17, seconded by Eagan. Motion carried.

The Chair stated that the next item on the agenda was *Hearing from Citizens* and asked any citizen who wished to speak to come forward.

Jessica Ponder, 1480 St. Catherine, introduced herself to the residents of Florissant. She is a candidate for the upcoming election for board member for the Ferguson-Florissant School District.

Joshua Polsky, 748 Loekes Dr., recapped information regarding bite statistics relating to the BSL and its ineffectiveness in controlling dangerous dogs. HB905 has been introduced at the state legislature and, if passed, will prevent local municipalities from banning specific breeds of dogs.

Connie Nolan, 170 Ruth Dr., thanked Councilmembers' Pagano and Caputa for introducing legislation tonight that would repeal the BSL. The media has not presented an accurate version of pit bull dogs.

Andrea Castleberry, 5414 Blow St., asked the City Council to please repeal the BSL, as statistics support that it is not effective legislation.

Lori Stimac, 3866 Grand National, stated that she owned two wonderful pit bull dogs and they couldn't be more loving with her family and grandchildren.

She suggested a possible compromise: that pit bull dogs allowed into Florissant be neutered. Pit bulls are abused, not socialized and used for nefarious reasons. Their reputation has nothing to do with the inherent breed.

Joan Swanston, 116 Birkdale, stated that Florissant residents, as tax payers, have a right to own any kind of dog. Throughout recent history, many different breeds of dogs have been deemed "dangerous" in the court of public opinion - now it is the pit-bull's turn. She asked the Council to repeal the BSL in Florissant.

Theresa Schmidt, 10344 Sannois Dr, asked that the discriminatory BSL be repealed. She feels irresponsible dog owners are at fault. Many notable organizations oppose the BSL.

Larry Appel, 1485 Lindsay, expressed his concern about the speeding and traffic on Lindsay Lane.

Alan Jones, 665 S Skinker, stated that the issue is not that pit bulls bite more frequently, but that their bite is stronger and does more harm. He supported the BSL.

Karon McCoy, 1866 Basket Oak Drive, asked that the BSL be repealed. She has owned a pit bull for many years and another one is being trained to be a therapy dog.

Sean Madden, 93 North Oaks Plaza, informed the residents about the St. Louis Youth Build/AmeriCorps. This program is a pre-apprentice program for youth who have dropped out of school and need help getting a GED. They are taught carpentry and construction skills and the program lasts 8-12 months. It is currently open enrollment time.

The next item on the Agenda was Public Hearings.

The City Clerk reported that Public Hearing #16-09-026 to be held this night on a request to rezone for Lyons Properties, LLC d/b/a Dunkin Donuts the property located at 8115 N. Lindbergh from B-3 "Extensive Commercial District" to B-5 "Planned Commercial District" to allow for the construction of a new building had been advertised in substantially the same form as appears in the foregoing publication and by posting the property. The Chair declared the Public Hearing to be open and invited those who wished to be heard to come forward.

Chairman Eagan stated that the petitioner had requested a continuance. Being no citizens who wished to speak, Councilman Eagan moved to postpone P.H. #16-09-026 to 3/13/2017, seconded by Jones. Motion carried.

The City Clerk reported that Public Hearing #17-02-004 to be held this night on a request to issue an amendment to B-5 Ordinance No. 6868 to allow for a new sit-down, carry-out restaurant with signage for the property located at 2180 N. Highway 67 had been advertised in substantially the same form as appears in the foregoing publication and by posting the property. The Chair declared the Public Hearing to be open and invited those who wished to be heard to come forward.

Michael Mueller, representative for McAlister's, stated that the proposed site is the old Bob Evans Restaurant on Lindbergh. The existing brick on the building will remain "as is" but they will be adding a 700 square foot patio on the "bank" side of the building, to be accessed only through the restaurant. The parking will remain the same. There will be a sidewalk off of the back patio for

emergency egress from the patio itself. There is some existing landscaping around the patio which will be removed and replaced with new landscaping to match existing. Initially staff expressed concern about traffic coming across the "bank" side onto the patio itself. Mr. Mueller explained that the patio was 2 feet above the existing grade and Mr. Lum felt that would be sufficient.

The brick will remain the same and the red awnings will be replaced with hunter green awnings. The faux EIFS on the east and west elevations will be painted to match the bronze on the doors at the back of the building. There will be a new awning located over the patio area. The patio will be smoke free. The Bob Evans "tower" will be removed and McAlister's will be put in its place. A sign package was submitted. The existing red lights on the side of the building will be painted black. The lights will not flash but will be steady and turned on during business hours only. No traffic study will be completed as it will be approximately the same as it was Bob Evans. The petitioner stated that the outside concrete foundation will be painted to match the band of brick above the awnings. The petitioner didn't want just a gray concrete slab to be exposed. Bushes will hide the concrete foundation as well. There will be no drive – thru as this restaurant. The Mayor asked the petitioner to install pedestrian trash receptacles on the site.

The Chair asked if there were any citizens who would like to speak on said public hearing. Linda Church, 13 McNulty, asked if there was any way that a vehicle could hit the patio to which the petitioner stated no, any traffic would be stopped.

Kevin O'Donnell, 512 Rancho Lane, thanked the Mayor and Councilman Eagan for requesting trash receptacles on site.

Mike Cardenes, 2475 Stoney End Ct, thanked McAlister's for opening a restaurant in Florissant. Being no other citizens who wished to speak, Councilman Siam moved to close P.H. #17-02-
