

What is Prop A?

Proposition A is a 20-year general obligation Bond Issue for Aquatic Recreational Projects. It requires a 4/7th (57.142%) majority to pass. If passed it will generate \$10 million for major new improvements and renovation of Florissant's aquatic recreation facilities.

What is the cost?

The general obligation bond is based on the assessed value of one's home. For example, for a \$10 million general obligation bond financing, the tax rate would be approximately 12 cents. The cost to an average \$150,000 homeowner would be approximately \$2.85 per month.

What are the benefits?

Rebuilding and improving outdated facilities make the overall pool and aquatic experiences more enjoyable for all. Providing modern facilities and upgraded aquatic recreational facilities enhances the overall desirability of Florissant as a great place to live and raise a family. It also directly contributes to the health and wellness for users of all ages.

How much will it cost to have Koch Pool, Bangert Pool rebuilt and to repair the indoor pool at the James J. Eagan Center?

If Proposition A does pass with 57% of the vote, a Request For Proposal (RFP) will be sent out for the City to receive proposals from pool companies on what the cost would be to re-build and repair the pools. **This process is open to the public**.

Is there or will there be money budgeted each year to maintain the pools. Yes. Each year the Department of Parks and Recreation budgets monies each year to maintain the pools.

Do the pools get resurfaced each year?

Yes. Each year money is budgeted for the pools to be resurfaced and every 3 to 5 years the pools will get sandblasted and resurfaced.

Will there be a price increase at pools?

Yes. How much has not been determined yet.

How will the city staff the pools?

The Department of Parks and Recreation will work closely with the Human Resources Department to host many recruiting campaigns to ensure the pools are fully staffed.

Why re-build two brand new pools instead of one?

With the City of Florissant being the largest city in the county the Pool Committee wanted to have the opportunity to have two updated fully renovated pools on both sides of town to consider.
