VI. <u>New Business</u>

PZ05052025-01. A request to paint exterior brick walls to meet corporate brand changes at 370 North Hwy 67 in a B-3 Extensive Business District (Ward 3)

Avi Khemlani Jimmy John's 370 North Hwy 67 Florissant MO 63031

Debbie Irvin, Building Commissioner, stated the request is to change the existing brick color to match the new corporate branding.

Avi Khemlani, owner, stated the building was last stained in 2014 and corporate is changing the branding from black to dark gray and red. He noted the black stain makes the building hotter in the summer. Mr. Khemlani stated he would be willing to stain the brick if they were not comfortable with him painting the brick.

Vice Chairman Nelke noted he cannot paint the brick, but he can stain the brick again.

Commissioner Jearls noted the stain seems to be peeling on the building and he does not want the brick painted. He stated he would prefer a high gloss stain.

Mr. Khemlani noted he would be sanding and painting the bollards but will only stain the building with the approved Sherwin Williams colors per the corporate requirements.

Vice Chairman Nelke moved to recommend approval to the City Council amending Special Use 8097 to change the color of existing brick building with stain to meet the corporate brand changes at 370 N Highway 67 in accordance with Section 505.060(D).
