54	Request ratification of a minor change to allow for security gates in a 'B-5', Ord 6669 (as		
55	amended by ords. nos. 6797, 6844, 6867, 6961, 7019, and 8527).		
56	Phil Lum noted this business is wanting security gates along the entry doors while the business		
57	is closed. Mr. Lum stated Ordinance 8704 prohibits fixed bars and grills on windows and doors. Mr.		
58	Baranowski noted certain businesses have been given approval for pull-down gates to add security.		
59	Chris Castleberry, petitioner, noted the gates are completely closed when the store is open, the steel		
60	gates are painted black and sit 2 inches away from the window on tracks. Jeremy Brown, director of		
61	construction, noted the business will do anything the commission asks of them. Many commission		
62	members noted their preference to have the gates stacking behind the wall.		
63	Chairman Olds made a motion for ratification of conditional approval for a minor change in a		
64	'B-5', Ord. 6669 (as amended by ords. nos. 6797, 6844, 6961, 7019, and 8527) to allow for scissor		
65	gates to be installed as conditionally approved by the Building Commissioner, stacking behind the wall		
66	when the business is open so as not to be seen within the window opening.
