The hill crests half way between Queens on one end and St Jean at the other.

She states people are routinely speeding up to 70 mph(at least in her estimation) and is asking for 2 things:

1. More attention to the area in terms of enforcement
2. Placing a stop sign at the crest of the hill so a speeding vehicle doesn't come blind over the hill.

Hey Karen,  
I have a resident requesting a stop sign after several accidents in front of her home.  
The request is for the intersection of St. Joseph and Lafayette.

The issue seems to be an assumption from drivers crossing Lafayette via St. Joseph that there is a 4-way stop. This assumption may be because similar 4-ways exist at St. Antoine, St Denis and St. Louis along Lafayette.

At the very least; and perhaps in the meantime, I think we should have signage that notes "Cross traffic does not Stop" on both sides of St. Joseph at Lafayette.
